



## VOLUNTARY SELF-EXCLUSION FORM

The Ho-Chunk Gaming - Wisconsin (HCG-Wisconsin) Gaming Enterprises offers you the opportunity to voluntarily exclude yourself from their facilities. The self-exclusion is considered permanent and irrevocable. The Ho-Chunk Nation, by and through the Gaming Enterprises Security Departments will make a reasonable effort to deny you access, but will not accept responsibility in the event that you fail to comply with this self-initiated exclusion.

Authority for this self-exclusion is granted in the Ho-Chunk Nation Gaming Ordinance Chapter 23(a).

### **POLICY:**

I voluntarily seek to exclude myself.

I agree that I will not attempt to enter and/or use any of the services or privileges of any of the HCG-Wisconsin Gaming Enterprises. If I enter any HCG-Wisconsin Gaming Enterprises or prohibited non-gaming area and I am detected, I request and consent to being evicted from the Gaming Enterprise immediately. I acknowledge that I may be arrested and prosecuted for trespassing and other violations of criminal law.

I acknowledge and understand that should I attempt to enter any of the HCG-Wisconsin Gaming Enterprises or use the services of the Gaming Enterprises during the Term of Exclusion, once identified, I shall be escorted from the Gaming Enterprise and any winnings or prizes, including but not limited to jackpots, chips, tokens, machine credits, or ticket vouchers, that are obtained by, or owed to me as a result of wagers made, will be confiscated and remitted by HCG-Wisconsin for deposit into the Ho-Chunk Nation's General Fund.

I understand that the ultimate responsibility to limit my access to the HCG-Wisconsin Gaming Enterprises is mine alone.

I am waiving any right to any complimentary products or other benefits that I may have earned in any player reward program, and that those complimentary products and benefits shall be void and uncollectible.

HCG-Wisconsin Gaming Enterprises will take reasonable steps to remove my name from mailing lists and other means of marketing. If I continue to receive any promotional materials from a Gaming Enterprises after the date of this request, I agree to immediately notify the marketing department of the Gaming Enterprises sending the information. I acknowledge that any promotional materials received by me by mail or electronically are not an invitation to return to the Gaming Enterprises that sent the information.

If I am or become a Ho-Chunk Nation employee or employee or agent of an entity which conducts business with HCG-Wisconsin Gaming Enterprises, I understand I will not be subject to eviction while engaged in work-related activities. I agree to abide by all other terms of the exclusion while engaged in work-related activities and to leave the Gaming Enterprise or prohibited non-gaming area immediately upon concluding such activities. If I do not abide by all other terms of the exclusion while engaged in work-related activities or I fail to leave the Gaming Enterprise or prohibited non-gaming areas upon concluding such activities, I request and consent to being evicted from the Gaming Enterprise immediately and acknowledge I may be arrested and prosecuted for trespassing or other violations of criminal law.

I understand that disclosure of certain information is necessary to affect my request for self-exclusion. Disclosure may also occur if needed for the conduct of an official investigation or if ordered by a court of competent jurisdiction.

I will not seek to hold the Gaming Enterprise liable in any way should I enter a Gaming Enterprise and/or use any of the services or privileges therein despite this exclusion request, and I agree to indemnify the Ho-Chunk Nation and the HCG-Wisconsin Gaming Enterprises for any liability relating to this request. Specifically, I for myself, my heirs, executors, administrators, successors, and assigns, hereby release and forever discharge the

Ho-Chunk Nation and the HCG-Wisconsin Gaming Enterprises, their agents, employees, officers, and Directors and those with whom they may lawfully share information regarding this exclusion (collectively, the Released Parties) from any and all claims in law or equity that I now have, or may have in the future, against all or any of all of the Released Parties arising out of, or by reason of, the performance or non-performance of this self-exclusion request, or any matter relating thereto. I further agree, in consideration for the Released Parties efforts to implement my exclusion, to indemnify and hold harmless the Released Parties to fullest extent permitted by law for any and all liabilities, judgments, damages, and expenses of any kind, including reasonable attorney's fees, resulting from or in connection with the performance or non-performance of the self-exclusion requested herein.

I declare that all information submitted on or with this self-exclusion form is true, correct, and complete.

I have accepted the terms and conditions of the Declaration.
